- 3. Please note on non receipt of space rental as per the payment schedule organizer reserve the rights to cancel / modify / change the allotted booth to the specified exhibitor.
- 4. Organiser reserve the rights to cancel the allotted space in case of failure of mutual terms between organizer and exhibitor.
- 5. Under no circumstances the payment / advance received against stall rental will be adjusted / refunded if exhibitor withdraw their participation.
- 6. In case of natural calamity, violence / strike or any other unforeseen / unavoidable circumstances organiser reserve the right to change the venue /date or postpone the venue / date.

7. INSURANCE, INDEMNITY BY THE EXHIBITOR AND THE ORGANISER EXCLUSION OF LIABILITY:
